# The Singular Limit of the Dissipative Zakharov System

The dissipative Zakharov system which models the propagation of Langmuir waves in plasmas is considered on the interval $[0, L]$. We are interested in the case of large ion acoustic speed $\lambda$. After the formal limiting transition $\lambda \rightarrow \infty$ this system turns into the coupling system of the parabolic and Schrödinger equations. We prove that this limit system has a solution and generates a dissipative dynamical system possessing a global compact attractor. Our main result is the upper semicontinuity of the attractor as $\lambda \rightarrow \infty$.

Key words: dissipative dynamical system, dissipative Zakharov system, global compact attractor.

## Introduction

The description of the propagation of Langmuir waves in plasma by the system of coupled equations

was proposed by Zakharov in [12]. Here $E: \mathbb{R}_{x} \times \mathbb{R}_{t}^{+} \rightarrow \mathbb{C}$ and $n: \mathbb{R}_{x} \times \mathbb{R}_{t}^{+} \rightarrow \mathbb{R}$. The complex function $E$ represents the slowly varying envelop of the highly oscillating electric field, and $n$ is the fluctuation of the ion density about its equilibrium value. The parameter $\lambda$ is proportional to the ion acoustic speed (see [12]).

In this paper we are interested in the one-dimensional dissipative case

where a positive damping parameter $\gamma$, the external forces $f(x)$ and $g(x)$ are given. For simplicity, we denote $\varepsilon=\lambda^{-2}$ and consider the case $\varepsilon \rightarrow 0$. This limit corresponds to the assumption that the plasma responds instantaneously to variations in the electric field (see discussion in [9]).

Formally letting $\varepsilon$ tend to 0 , we obtain the system

In the paper, we prove that the system (3) with Dirichlet boundary conditions has the unique strong solution for every initial data in the corresponding energy space. Moreover, this problem generates the dissipative dynamical system possessing the compact global attractor $\mathcal{A}$. Our main result is the proof of the convergence of the attractors $\mathcal{A}_{\varepsilon}$ for the system (2) to $\mathcal{A}$ as $\varepsilon \rightarrow 0$.

The limit $\lambda \rightarrow \infty$ for the Zakharov problem (1) without dissipation for $x \in \mathbb{R}^{d}$, $d \leq 3$, was studied in [9]. But this result concerns sufficiently smooth solutions on the finite interval $[0, T]$.

A similar problem was studied in [1] for the system of Shrödinger and KlienGordon equations with Yukawa coupling

in the bounded domain $\Omega \subset \mathbb{R}^{n}, n \leq 3$. The case $\beta, \gamma \rightarrow 0$ was considered and the convergence (on each finite time interval) of the corresponding solutions of this system to those of the limit problem was proven. But this result was obtained for the case where the ratio $\gamma / \beta$ belongs to a fixed interval $[1, M]$.

The system (2) with Dirichlet boundary conditions was studied by Flahaut in [4]. The author proved that this problem has a unique solution and generates a dynamical system in the energetic spaces $\mathcal{E}_{1} \equiv L_{2} \times H_{0}^{1} \times\left(H_{0}^{1} \cap H^{2}\right)$ and $\mathcal{E}_{2} \equiv H_{0}^{1} \times\left(H_{0}^{1} \bigcap H^{2}\right) \times\left(H_{0}^{1} \cap H^{3}\right)$. Moreover, it was shown that there exists a bounded absorbing set and a weak attractor for this system. This result was improved by O. Goubet and I. Moise [5]. They proved the existence of the (uniform) compact global attractor $\mathcal{A}_{2} \subset \mathcal{E}_{2}$ for the Zakharov problem with Dirichlet boundary conditions. This attractor $\mathcal{A}_{2}$ is also a global attractor in the space $\mathcal{E}_{1}$. It means that the global attractor in $\mathcal{E}_{1}$ possesses additional spatial smoothness.

The case of periodic boundary conditions for the system (2) was studied in [7]. It was proven that the elements of the global attractor for the dissipative Zakharov system with periodic boundary conditions are the analytic functions of the spatial variable.

Zakharov's system with two spatial variables was studied in $[2,8]$. The existence of the global attractor was shown under the conditions which hold in the case of large enough $\gamma$ or for the thin domain. Another interesting example of the interaction of the wave and quantum dynamics is Schroedinger-Boussinesq equtions (see [3] and references therein).

The paper is organized as follows. In Sec. 1, we obtain some $\varepsilon$-uniform estimates for the solution of (2). In Sec. 2, we prove that the problem (3) has a unique solution and generates the dissipative dynamical system possessing a compact global attractor. In Sec. 3, we prove the convergence of the attractors $\mathcal{A}_{\varepsilon}$ to $\mathcal{A}$ as $\varepsilon \rightarrow 0$.

## 1. The $\varepsilon$-Uniform Estimates

In this section we consider the problem (2) with Dirichlet boundary conditions

\end{equation*}

We recall that it was proven for every $\varepsilon>0$ that the problem (2), (4) is wellposed in the spaces $\mathcal{E}_{1} \equiv L_{2}(\Omega) \times H_{0}^{1}(\Omega) \times\left(H_{0}^{1}(\Omega) \bigcap H^{2}(\Omega)\right)$ and $\mathcal{E}_{2} \equiv H_{0}^{1}(\Omega)$ $\times\left(H_{0}^{1}(\Omega) \bigcap H^{2}(\Omega)\right) \times\left(H_{0}^{1}(\Omega) \bigcap H^{3}(\Omega)\right)$ (see [4]). We also recall that this problem generates the dissipative dynamical system in $\mathcal{E}_{1}$ possessing the global compact attractor $\mathcal{A}_{\varepsilon} \subset \mathcal{E}_{2}$ (see [5]).

Our goal is to obtain the $\varepsilon$-uniform estimates. The proof is split into several steps presented as separate lemmas. All of these lemmas contain a common part. We consider a functional $W_{k}(U(t))$ which is equivalent to the square of the norm of $U(t) \equiv\left(n_{t}(t), n(t), E(t)\right)$ in the corresponding phase space. Then we compute the derivative of this functional on the trajectories and obtain the inequality of the type

where $\eta_{k}$ is a suitable constant which does not depend on $\varepsilon$. Then we estimate the terms in $R_{k}(t)$ and get

Using the Gronwall lemma, we have

W_{k}(U(t)) \leq W_{k}(U(0)) e^{-\eta_{k} t}+C\left(1-e^{-\eta_{k} t}\right) / \eta_{k},
$$

which implies $W_{k}(U(t)) \leq C$. Since $W_{k}(U(t))$ is equivalent to the $\|U(t)\|^{2}$, we obtain the necessary estimates.

To estimate the nonlinear terms in $R_{k}(t)$, we have to recall two well-known functional inequalities which will be useful for us. The first of them is the Agmon inequality

where $\|\cdot\|$ denotes the usual $L_{2}(\Omega)$ norm. And the second one is the GagliardoNirenberg inequality

We note also that formally we consider $W_{k}\left(U_{N}(t)\right)$, where $U_{N}(t)$ is the Galerkin approximation of $U(t)$. Therefore, first we prove our estimates for $U_{N}(t)$ and then pass to the limit as $N \rightarrow \infty$. However, for simplicity, we omit this procedure.

We start from the following.
Lemma 1.1. Suppose that $\varepsilon$ belongs to $\left[0, \varepsilon_{0}\right], f \in L_{2}(\Omega), g \in H^{1}(\Omega)$ and let $\left(n_{t}, n, E\right)$ be a solution of (2), (4) in $\mathcal{E}_{1}$. Then there exists $\kappa_{0}$ such that

where $C_{i}$ does not depend on $\varepsilon$ and $C_{1}$ does not depend on the initial data.
Proof. Testing (2) by $E$ and taking the imaginary part of the result, we get

Since

then the Gronwall lemma implies

Let us define the functional

where $\|\cdot\|_{-1}$ and $(\cdot, \cdot)_{-1}$ are $\left\|(-\Delta)^{-1 / 2} \cdot\right\|$ and $\left((-\Delta)^{-1 / 2} \cdot,(-\Delta)^{-1 / 2} \cdot\right)$, respectively, and the positive parameter $\eta_{0}$ will be chosen later.
Since

& \frac{\mathrm{d}}{\mathrm{dt}}\left\{2 \varepsilon\left(n_{t}, n\right)_{-1}+\|n\|_{-1}^{2}\right\}=2 \varepsilon\left\|n_{t}\right\|_{-1}^{2}-2\|n\|^{2}-2\left(n,|E|^{2}\right)+2(n, f)_{-1}, \\
& \begin{aligned}
& \mathrm{d} \\
& \mathrm{dt}\left.2\|\nabla E\|^{2}+4 \Re(g, E)+2\left(|E|^{2}, n\right)\right\}=
\end{aligned} 2\left(n_{t},|E|^{2}\right)-4 \gamma\|\nabla E\|^{2} \\
&-4 \gamma\left(n,|E|^{2}\right)-4 \gamma \Re(g, E),
\end{aligned}

by addition we get

R_{0}(t)=2 \eta_{0}(f, n)_{-1}-2\left(\eta_{0}+2 \gamma\right)\left(|E|^{2}, n\right)-4 \gamma \Re(g, E) \tag{11}
\end{equation*}

We note that it follows from (6) and (8) that

\|E\|_{L_{4}} \leq C\|E\|^{3 / 4}\|\nabla E\|^{1 / 4} \leq\left(C_{1}+C_{2} e^{-\gamma t}\right)\|\nabla E\|^{1 / 4}
$$

where $C_{1}$ is independent of the initial data. Therefore,

\left|\left(n,|E|^{2}\right)\right| \leq C\|n\|\|E\|_{L_{4}}^{2} \leq\left(C_{1}+C_{2} e^{-\gamma t}\right)\|n\|\|\nabla E\|^{1 / 2}
$$

Taking into account this inequality, it is easy to see that

Substituting (12) into (10), we get

Now we put $\eta_{0}=1 /\left(2 \varepsilon_{0}\right)$ and $\kappa_{0}=\min \left\{\varepsilon_{0} / 4, \gamma\right\}$. Then, for sufficiently small $\varepsilon_{0}$, from (13) we obtain

Taking into account (13), we deduce (7) from the Gronwall lemma.
Lemma 1.2. Let $\varepsilon$ belong to $\left[0, \varepsilon_{0}\right], f \in L_{2}(\Omega), g \in H^{1}(\Omega)$ and let $\left(n_{t}, n, E\right)$ be a solution of (2), (4) in $\mathcal{E}_{1}$. Then there exists $\kappa_{1}$ such that

where $C_{i}$ does not depend on $\varepsilon$ and $C_{1}$ is independent of the initial data.

Proof. Let us consider the functional

From the Agmon inequality (5) and (7) we obviously have $\|E(t)\|_{L_{\infty}} \leq C_{1}+$ $C_{2} e^{-\kappa_{0} t}$. Therefore,

It is easy to prove that

& \frac{\mathrm{d}}{\mathrm{dt}}\left(\|\Delta E\|^{2}-2 \Re(n E, \Delta E)-2 \Re(g, \Delta E)\right)=-2 \gamma\|\Delta E\|^{2}-2 \Re\left(n_{t} E, \Delta E\right)+R_{1,1}(t),

\frac{\mathrm{d}}{\mathrm{dt}} W_{1}(t)+\frac{3}{4}\left\|n_{t}\right\|^{2}+\frac{3 \eta_{1}}{4}\|\nabla n\|^{2}+\frac{3 \gamma}{2}\|\Delta E\|^{2} \leq C_{1}+C_{2} e^{-\kappa_{0} t} . \tag{21}
\end{equation*}
$$

We can see from (17) that for $\kappa_{1}=\min \left\{\varepsilon_{0} / 8, \gamma / 2\right\}$ the following relation is true:

& \frac{\mathrm{d}}{\mathrm{dt}}\left(\varepsilon\left(\nabla n_{t}, \nabla n\right)+\frac{1}{2}\|\nabla n\|^{2}\right)=\varepsilon\left\|\nabla n_{t}\right\|^{2}-\|\Delta n\|^{2}-\left(\Delta n, \Delta|E|^{2}\right)+(\Delta n, f) .
\end{aligned}

Taking into account that the second equation of (2) implies that $E_{t}=i \Delta E$ $-i n E-\gamma E-i g$, one can obtain

& +6 \Im(\nabla n \Delta E, \nabla \Delta E)-6 \gamma \Re(\nabla E \nabla n, \Delta E)-6 \Im(\nabla n \Delta E, \nabla g) \\
& +2 \Re\left(\Delta n \Delta E, E_{t}\right)-6 \Im(\nabla n \Delta E, E \nabla n+n \nabla E) . \tag{25}

Put $\eta_{2}=1 /\left(4 \varepsilon_{0}\right)$ and $\kappa_{2}=\min \left\{\varepsilon_{0} / 2, \gamma\right\}$. Then (24) and (26) imply that

& \quad \leq C\|\nabla \Delta E\|, \\

where $\eta_{3}=1 /\left(4 \varepsilon_{0}\right)$. We note that it follows from (22) and the first equation of (2) that $\|\nabla u\| \leq C$. Therefore,

& +2 \eta_{3} \Re(m u, \Delta E)+4 \eta_{3} \Re(m \nabla u, \nabla E)+2\left(\eta_{3}+\gamma\right) \Re(m E, \Delta u)  \tag{34}\\
& -2 \Im(\Delta(n u), m E)+2 \Im(u \Delta n+2 \nabla n \nabla u, \Delta u) .

& \left|\left(m E_{t}, \Delta u\right)\right| \leq\|\nabla u\|\left(\|\nabla m\|\left\|E_{t}\right\|_{L_{\infty}}+\left\|\nabla E_{t}\right\|\|m\|_{L_{\infty}}\right) \leq C\|\nabla m\|, \\
& |(m u, \Delta E)| \leq\|m\|_{L_{\infty}}\|u\|\|\Delta\| E\|\leq C\| \nabla m \|, \\
& |\Re(m \nabla u, \nabla E)| \leq\|m\|\|\nabla u\|\|\nabla E\|_{L_{\infty}} \leq C\|\nabla m\|, \\
& |(\Delta(n u), m E)| \leq\|\nabla u\|\|n\| \|_{L_{\infty}}\left(\|\nabla m\|\|E\|_{L_{\infty}}+\|\nabla E\|\|m\|_{L_{\infty}}\right) \\

## 2. The Limit Problem

This section is devoted to the investigation of the long time behavior of the solution of the system (3), (4). We understand the solutions of this problem in the sense of the following definition.

Definition 2.1. A pair $(n ; E)$ is said to be semi-strong to the problem (3), (4) on $[0,+\infty)$ iff

(n ; E) \in L_{\infty}\left([0,+\infty) ; H_{0}^{1}(\Omega) \times H_{0}^{1}(\Omega) \bigcap H^{2}(\Omega) \equiv \mathcal{H}\right) \tag{36}
\end{equation*}

(i) the first two relations in (3) are fulfilled in the sense of distributions, (ii) the initial data hold.

We call this solution "semi-strong" because it is weak with respect to $n$ and strong with respect to $E$.

### 2.1. Existence and uniqueness of the solution

Our first result is the following theorem.
Theorem 2.1. Let the initial data $\left(n_{0}, E_{0}\right)$ belong to $\mathcal{H}$ and the external forces $f(x)$ and $g(x)$ belong to $L_{2}(\Omega)$ and $H_{0}^{1}(\Omega)$. Then the system (3), (4) has a unique semi-strong solution on $R^{+}$.
2.1.1. Existence. The proof of the existence is based on the compactness method. We define $P_{N}$ as a projector on the first $N$ eigenvectors of the operator $-\Delta$ with Dirichlet boundary conditions. Let us consider the approximation of the system (3):

$$

This system is a system of ordinary differential equations. Hence, there exists the local (in time) solution $\left(n^{N}, E^{N}\right)$ on $\left[0, T_{N}\right]$. We note that Lemma 1.1 and Lemma 1.2 remain true for $\varepsilon=0$. Then from (14) we get that $\left(n^{N}, E^{N}\right) \in$ $L_{\infty}\left(R^{+}, \mathcal{H}\right)$. Hence, for any $T>0$, we get that $\left(n^{N}, E^{N}\right)$ belongs to a bounded
set in $L_{\infty}((0, T), \mathcal{H})$. Then there exists a subsequence, still denoted by $\left(n^{N}, E^{N}\right)$, such that there exists $(n, E) \in L^{\infty}((0, T), \mathscr{H})$ such that $\left(n^{N}, E^{N}\right) \rightarrow(n, E)$, which is weak-star in $L^{\infty}((0, T), \mathcal{H})$, as $N \rightarrow \infty$.

Let us prove that ( $n, E$ ) satisfies (3). Since $n^{N}$ and $E^{N}$ belong to the bounded sets in $L_{\infty}\left((0, T), H^{1}\right)$ and $L_{\infty}\left((0, T), H^{2}\right)$, respectively, $n_{t}^{N}=\Delta\left(n^{N}\right.$ $\left.+P_{N}|E|^{2}\right)+P_{N} f$ and $E_{t}^{N}=i \Delta E^{N}-i P_{N}\left(n^{N} E^{N}\right)-\gamma E^{N}-i P_{N} g$ belong to $L_{2}\left((0, T), H^{-1}\right)$ and $L_{2}\left((0, T), L_{2}\right)$. It follows from Aubin's imbedding theorem (see [10, Corollary 4]) that there exists a new subsequence $\left(n^{N}, E^{N}\right)$ such that $\left(n^{N}, E^{N}\right) \rightarrow\left(n^{*}, E^{*}\right)$ strongly in $C\left(0, T ; L_{2} \times H_{0}^{1}\right)$. It is easy to see that $n^{*}=n$ and $E^{*}=E$. Thus we can pass to the limit in the nonlinear terms.
2.1.2. Uniqueness. The uniqueness of the solution of (3) follows from the next proposition.

Proposition 2.1. Suppose $\left(n^{(1)}, E^{(1)}\right)$ and $\left(n^{(2)}, E^{(2)}\right)$ are two solutions of (3) in $\mathcal{H}$ with the initial data $\left(n_{0}^{(1)}, E_{0}^{(1)}\right)$ and $\left(n_{0}^{(2)}, E_{0}^{(2)}\right)$, respectively, which belong to the ball of radius $R$ in $\mathcal{H}$. Then

$$
\begin{equation*}
\|\nabla n(t)\|^{2}+\|\Delta E(t)\|^{2} \leq C_{R}\left(\left\|\nabla n_{0}\right\|^{2}+\left\|\Delta E_{0}\right\|^{2}\right) e^{t C_{R}} \tag{38}
\end{equation*}
$$

where $n=n^{(1)}-n^{(2)}, E=E^{(1)}-E^{(2)}, n_{0}=n_{0}^{(1)}-n_{0}^{(2)}$ and $E_{0}=E_{0}^{(1)}-E_{0}^{(2)}$.
Proof. First, we prove the estimate (38) for Galerkin's approximations. Then, passing to the limit, we obtain (38) for the solutions of (3).

For simplicity, we omit index $N$ of the number of Galerkin's approximations.
Since the initial data belong to the ball of radius $R$ in $\mathcal{H}$, then there exists a constant $C_{R}$ such that

Let us rewrite now the second equation from (40) in the form

We note that since Lemma 1.2 remains true for $\varepsilon=0$, then the following proposition holds.

Proposition 2.2. The problem (3) generates the dissipative dynamical system $S(t):\left(n_{0}, E_{0}\right) \in \mathcal{H} \rightarrow(n(t), E(t)) \in \mathcal{H}$.

### 2.2. Existence of the Global Attractor for the limit system

Our goal is the proof the following result concerning the existence of the compact global attractor in $\mathcal{H}$.

Theorem 2.2. Let $f(x)$ and $g(x)$ be the functions from $L_{2}(\Omega)$ and $H_{0}^{1}(\Omega)$. Then the problem (3) generates the dynamical system possessing a compact global attractor $\mathcal{A} \in \mathcal{H}$.

The proof of the existence of the global attractor is based on the well-known theorem of the general theory of dynamical systems (see, for instance, [11, Theorem I.1.1]). We construct a decomposition of the evolution operator $S(t)$ as $S_{1}(t)+S_{2}(t)$ with the properties required in Theorem, i.e.,
(1) $S_{1}(t)$ is uniformly compact in $\mathcal{H}$ for $t$ large, i.e., for any bounded set $B$ there exists $t_{0}$ such that the closure of $\bigcup_{t \geq t_{0}} S_{1}(t) B$ is a compact set in $\mathcal{H}$.
(2) $S_{2}(t): \mathcal{H} \rightarrow \mathcal{H}$ is continuous for any $t \geq 0$, and for any bounded set $B_{1} \subset \mathcal{H}$, the following relation holds:

Then there exists the time of dissipation $t_{0}=t_{0}(\mathcal{B}, R)$ such that $S(t)\left(n_{0}, E_{0}\right) \in \mathcal{B}$ for $\forall t \geq t_{0}$. Thus,

Thus we need only to prove the uniform estimate (51) for the solution on any interval of the existence. To simplify notations below, we omit the subscript $M$.

We prove (51) in several steps. First, we prove that

Step 2. Let us take now the real part of the inner product in $L_{2}$ of the second equation from (50) with $4 \Delta Z_{t}+4 i \gamma \Delta Z$ :

& \left|\left(p_{t} \nabla y, \nabla Z\right)\right| \leq\left\|p_{t}\right\|\|\nabla y\|_{L_{4}}\|\nabla Z\|_{L_{4}} \leq C\left\|p_{t}\right\|\|\Delta Z\|^{1 / 4} .
\end{aligned}

These inequalities and (67) yield

&\left|\left(p Q_{N}(p \chi+q E), \Delta \chi\right)\right| \leq\|p\|_{L_{\infty}}^{2}\|\chi\|\|\Delta \chi\|+\left(\|\nabla q\|\|E\|_{L_{\infty}}+\|q\|_{L_{\infty}}\|\nabla E\|\right)\|\nabla \chi\| \\
& \leq C \lambda_{N+1}^{-1 / 2}(\|\Delta \chi\|+\|\nabla q\|)\|\Delta \chi\| .

## 3. Convergence of the Attractors

Theorem 3.1. Suppose that the conditions of Theorem 2.2 are fulfilled. Then

with $\mathcal{A}$ being the global attractor for the problem (3), $\operatorname{dist}_{\mathcal{E}_{1}}(y, A)$ being a distance from the element $y$ to the set $A$ in the space $\mathcal{E}_{1}$.

Proof. It follows from (22) and (29) that there exists some constant $R_{1}$ such that for an any bounded set $B$ of the initial data there exists the moment $t_{0}(B)$ such that

It is evident that there exists an element $y_{\varepsilon}=\left(m_{0}^{\varepsilon}, n_{0}^{\varepsilon}, E_{0}^{\varepsilon}\right)$ such that

$$
\operatorname{dist}_{\varepsilon_{1}}\left(y_{\varepsilon}, \mathcal{A}^{*}\right)=\sup \left\{\operatorname{dist}_{\varepsilon_{1}}\left(y, \mathcal{A}^{*}\right), y \in \mathcal{A}\right\}
$$

Let $y_{\varepsilon}(t)=\left(n_{t}^{\varepsilon}(t), n^{\varepsilon}(t), E^{\varepsilon}(t)\right)$ be a complete trajectory such that $y_{\varepsilon}(0)=y_{\varepsilon}$. It follows from (93) that there exists the subsequence $\varepsilon_{k}$ and the element $y(t)=$ $\left(n_{t}(t), n(t), E(t)\right) \in L_{\infty}\left(\mathbb{R}, \mathcal{E}_{1}\right)$ such that $y_{\varepsilon_{k}}(t)$ tends to $y(t)$ as $\varepsilon_{k} \rightarrow 0$ on any interval $[a, b]$ in the weakly ${ }^{*}$ topology in $L_{\infty}\left([a, b], \varepsilon_{2}\right)$. From Aubin's imbedding theorem (see [10, Corollary 4]) it follows that $y_{\varepsilon_{k}}(t)$ tends to $y(t)$ strongly in $C\left([a, b], \varepsilon_{1}\right)$. Taking to the limit in (2) as $\varepsilon \rightarrow 0$ and using that $\varepsilon\left\|n_{t t}^{\varepsilon}\right\| \rightarrow 0$, we get that $y(t)$ is a bounded solution of the problem (3). Hence, $y(t)$ belongs to $\mathcal{A}^{*}$.
